

HCP Society Board Nominations

What does the Board do?

As a not-for-profit organization, the HCP is governed by a society led by a Board of Directors. The Board's function is to oversee HCP's strategic direction and financial performance, and upholds its operations, policies, and values.

The Board's mandate flows from the District of Saanich. Saanich owns the land that HCP resides on and charges the HCP Society for operating and stewarding these lands. The HCP Board undertakes this responsibility in accordance with the *BC Society Act*. From these leased premises, the HCP operates according to Board policies and the HCP Society Bylaws.

The HCP Board is actively seeking new Directors. We are particularly interested in people who have horticulture, finance, or HR experience. We are seeking a new Secretary and Treasurer. The time commitment is roughly 5 hours per month but could be higher depending on committee involvement.

Plans for 2025

Each year the HCP Society Board identifies its goals and priorities for the upcoming year. In addition to ongoing support to the management team, this year we are focused on identifying what steps are needed to address the current condition of HCP's buildings and infrastructure; on developing a long term vision and strategy for growth; and planning for HCP's 50th anniversary in 2029. This work may involve revisiting and updating the Strategic Plan and supporting Action Plan for delivery.

Renewing Directors

Four current Directors will be continuing for the second year of their current two-year terms: Britta Wagner (Secretary), Bryan Bonell, Joshua Craig, and Rani Wiedemann (see the HCP website for bios). Our current Chair, Brian White, will be starting his second two-year term.

In accordance with the HCP Society bylaws section 47(a) an elected Director's term of office is two consecutive years from the date of election. In accordance with section 48, an elected Director may serve for no more than six consecutive years. Each new Director is being elected for a two-year term.
